"THE TRUSTEES" (which expression shall, unless repugnant to the context be deemed to include the present TRUSTEES and their successors in office for the time being or their agents and assigns) of the OTHER PART.

WHEREAS THE SETTLER above named in the absolute owner of a sum of Rs.15,001/- (Rupees fifteen thousands one) only. AND WHEREAS the SETTLER above voluntarily decided to set up a charitable trust for the objects specified here-in-after and has handed over the said sum of Rs.15,001/- (Rupees fifteen thousands one) only up to the hands of the TRUSTEE named here-in above to hold the same for charitable purposes. Subjects to the terms and provisions declared hereby and confirmed by the TRUSTEES.

THE TRUSTEES above named have agreed to be the TRUSTEES and hold and apply the said sum of Rs.15,001/- (Rupees fifteen thousands one) only and all gifts, contributions, donations, grants, accretions and additions hereto, which they will receive and possess for and in the name of the Trust on its behalf for fulfilment of the objects of the Trust herein-under.



HOW THIS INDENTURE WITNESSSETH IS AS FOLLOWS:-

1. TRANSFER:-

That the SETTLER is the absolute owner of sum of Rs.15,001/(Rupees fifteen thousands one) only and hereby conveys, transfer and grants into the hands of the TRUSTEES named herein above to hold the same for the said Trust to carry out the objects and purposes and for wishes of the SETTLER according to the direction herein-below.

2. NAME:

That the name of the Trust be

"NISHANT EDUCATIONAL AND SOCIAL WELFARE TRUST"

3. OFFICE OF THE TRUST:

That the head office of the trust shall be situated at H-75, Harmu Housing Colony Harmu, P.O Harmu, P.S Argora, District Ranchi, Jharkhand PIN-834012.

The branch office shall be situated at

Gosepur Road, P.O:- Dalsingh sarai, Distt: - Samastipur, Bihar
Pin:-848 114.

4. THE TRUSTEES shall be at liberty to transfer the office or may open branch or branches at any place and/or places within the territories of India at their mutual consent/decision from time to time.

- That the settler declared to appoint Smt. Sujata Jagdish as the Managing Trustee who shall be the convener and Chairman /chair person to the said TRUST.
 - Not any thing contained in any other provisions of this deed Smt. Sujata Jagdish will continue as the chair person of the trust during her pleasure/ life time and shall not be able to be removed and after her, her son will be the successor and shall not be able to be removed.

The second trustee being the founder trustee will hold office till his life time and after him, his son will be the successor and shall not be able to be removed.

6. OBJECTS OF THE TRUST:

The Trustees shall spend, utilize and apply the Trust fund for all of any one or more of the under mentioned charitable objects and purposes or such other charitable objects, beneficial to public, as the TRUSTEES may think proper and in such manner in all respects as the TRUSTEES may in their absolute description deem fit and proper.

- A) The spread or promotion of education or learning in all its branches in such manner as the TRUSTEES may think fit including.
- Establishment and/or acquisition and maintenance or support of schools, colleges, vidyapiths, Balmandirs study centers, universities and professional Training Centers and others Institutions for imparting education and training to the students.
- ii) Establishment and support of professorships, Fellowships, Lectureships,
 Scholarships and prizes at schools, colleges or other Educational Institutions.
- iii) Establishment and maintenance of Hostels and/or Boarding houses and grant of free Boarding and lodging to poor and deserving students upon such terms and for such period to each case as the trustees may think fit.

- iv) Establishment and maintenance of any support of naturopathy and yoga, Health Centers and Similar institutions for the education of the same.
- v) Grant of Endowments at Universities, Research Institutions and other Educational and Scientific Institutions for spread of Education and Knowledge in all of any branches.
- vi) To organize seminars and workshops on scientific views, awareness and communication.
- vii) Establishment and maintenance of sports centers and providing education and training in sports of all types.
- viii) Establishment, maintenance and support of libraries, reading rooms and auditoriums for advancement of education and knowledge's in general and for rural peoples.
- ix) Establishment of training Centers for the development of drama, art dance, painting, fine art and magic shows.
- x) To establish a working relationship with the Government to assist in the programs run by them like Child Development programs, Non-formal Education, Audit Education, TREYSEM, DWCRA, MANREGA etc.
- xi) To organize training programs for the mental development of the adolescent and children.
- xii) To provide an overall development in the field of Education for the Schedule Castes. Minority, Schedule Tribe, Backward Classes, weaker section of the society, helpless and persons deprived of education.
- B. Affording of medical relief in such manner as the trustees may think fit including.
- I) Setting up of hospitals or others medical institutions and running them or granting or subscriptions and donations to hospitals, dispensaries,



convalescent homes, asylums, nursing homes and other public institutions for administering medical relief to the needy.

- ii) Endowments to and help or support to Hospitals, Maternity Homes and Dispensaries.
- iii) Grant of medical help to the poor and grant of medical help to deserving persons during epidemic, famine, flood, earthquake or any unforeseen calamity or war or war like operations, providing always also without prejudice to the generality of the foregoing that the helps to be given under any of the foregoing heads wherever the case may under any of the foregoing heads wherever the case may admits may be given in the way of pecuniary payments of goods or other things or the supply or distribution of goods, clothes or medical relief or any manner which the trustees may consider desirables.
- Establishment and maintenance of mobile clinic or clinics for eye, dental, cancer, general health and other elements.
- v) Encouragement of provision of sanitary facility and promotion of a preventive and other measures for the health of the people especially in rural or poverty stricken areas.
- vi) Establishment and maintenance of family planning and family welfare clinic.
- vii) In rendering health for eradication, prevention and cure of Leprosy.
- viii) Education in health, hygiene and sanitation, especially in the rural areas.
- ix) To set up educational institution, informal education, management colleges, colleges for technical education and other professional educational colleges.

- Establishment of Institution related to environmental activity games and sports.
- xi) To work in the field of health for physical, mental and intellectual development of malnourished children.
- xii) To establish nutrition centers for the pregnant women and children.

 Also to educate them in the value of nutrition and upbringing of children.
- xiii) To work towards eradication and prevention of AIDS.
- xiv) To work against wastage of medicines and support in prevention of alcoholic and drug habits.
- xv) To conduct social, financial and cultural programmers for the development of handicaps.
- xvi) To work against child labour and for children right.
- xvii) To encourage bravery activities among youths and children.
- xviii) To organize medical camps for diseases which are common among the people such as cataract etc.
- C. Ensuring raising Levels of better standard of living in an environment which is clean and eco-friendly as the TRUSTEES may think fit including:-
- i) To work in water sanitation areas for villages, colonies, Adivasi mushars and Harijan, Tolis, Minorities and shall also organize meetings and work shops for National Integrity and communal Harmony as and when required.
- ii) To provide training to Animal Husbandry, fisheries, dairy farms and poultry farms in order to increase their knowledge and also organize training and workshops on sericulture and apiculture.



- iii) To participate in various forestry schemes to ensure preservation of environment. To make people aware and observatory to the established for the tree plantations.
- iv) Focusing towards village development, work to be done in the field of agriculture.
- To implement programmers for financial, social and cultural development of tribal including protection of the original culture of the tribes.
- vi) To work towards empowerment of women in running the "women saving Scheme".
- vii) To implement tools of Micro Level planning and the participatory Rural Appraisal to ensure meeting of the development activities undertaken. Ensure training to be provided. To core groups for the fulfillment of the objectives.

viii) To establish maintain or arrange grants to organizations, Ashrams and/or institutions engaged in such activities:-

- a) Prohibition.
- b) Communal Harmoney
- c) Removal of untouchablity
- d) Upliftment of women and children.
- e) Drinking water
- f) Village sanitation of women and children
- g) Welfare of Tribals, Harijans, Adivasis, Labours, Students, Elderly physically and mentally handicapped and minority's welfares of abandoned and orphan children.



- h) Setting up of household and village industries:
- i) Information, Education, about AIDS and Treatment thereof.
- ii) Marriage of girls after marriageable age.
- Help to poor bereaved families to arrange for funeral of the dead etc.
- Environment protection and waste management.
- m) Family counseling
- n) Rehabilitation of destitute and abandoned women.
- o) Any other social service.
- Scholarships, Awards, prizes other allowances and concessions to students for their extra-ordinary Performance.
- x) To spread knowledge of the Vedas, the Shastras, the Purnas, the Ramayana, the Geeta, the Bible, the Guru Grantha Sahib, the Kuran and the Yoga's among the people by organizing conference, seminars, Pravachans and provide them facilities for prayer, gaining knowledge about cultural, spiritual and values, consciousness and love of God.

- xi) To establish, maintain and contribute to the Dharamsthalas,
- xii) To create any reserve fund, sinking fund, insurance fund provident fund or any other special fund whether for depreciation or for repairs, improvement extension or maintenance of any of properties or rights of the Trust and/or for recumbent of wasting assets and/or for benefits of the employees and for any other purpose for which the Trust deemed it expedient or proper to create or to maintain any such fund or funds.

7. The TRUSTEES shall, in case where any aid is proposed to be given for charitable purposes to any institutions, associations, Society, organizations, body or trust as certain whether the objects of such institution, association, society organization body or trust are in accordance with the objects of this trust and if so satisfied, may give donation to such institution, association, society, organization body or trust for being utilized only for such objects.

MANAGEMENT OF THE TRUST.

- a) The trust will be managed by a Board of TRUSTEES.
- b) There will be a governing council to assist the Board of Trustees on the "Board" by whatever name called.
- c) In case of any conflict between the decision of the Board of Trustees and the governing Council, the decision of the Board of Trustees shall be final and binding.

B. TRUSTEES:

a) The number of the TRUSTEES shall not be less than two and more than seven. If the number of the TRUSTEES falls below two, the remaining TRUSTEE shall not act on behalf of the TRUST except for the purpose of filling up a vacancy, as long as the number of TRUSTEES is below the minimum.

- b) The TRUSTEE for the time being will be at liberty to appoint additional TRUSTEE (S) within the number mentioned above, for such period or on such terms as to retirement and re-appointment as the TRUSTEES for the time being may consider proper. If any TRUSTEE dies, retires, becomes unfit or incapable to act, the continuing or surviving TRUSTEES OR TRUSTEE may appoint a TRUSTEE in place of the incapacitated TRUSTEE.
 - i) Leaves without consent.
- Does not attend three consecutive meetings of the Trust or fails to attend meetings for one calendar year, whichever is longer; or
- iii) Is requested to resign by 2/3 of the TRUSTEES or as near to this number as possible of the remaining TRUSTEES.
- d) The TRUSTEE is at liberty to resign from the Trust on giving one month's prior notice in writing of his or her intention to do so.

9. POWER OF THE TRUSTEES:

- A) The TRUSTEES shall be at liberty, at their absolute discretion to accept any property, contributions grants, collection or donations from persons, firm Companies of Government or other institutions, including foreign agencies/institutions or foreign Governments, for the advancements of the objects of the Trust.
- b) The TRUSTEES shall be entitled form time to time to open and maintain bank accounts in the name of the Trust with a bank or banks, to operate such accounts (s) and to give instructions to the bank (s) and to

provide for opening and operation of such accounts (s) by the two or more TRUSTEES or Agent (s) appointed by the TRUSTEES.

- c) The TRUSTEES may borrow or raise money or funds from banks, financial institutions, government, other institutions, persons, firms and companies for the purpose and the objects of the Trust, on such terms and conditions as they may think fit in the interest of the Trust and mortgage, pledge or otherwise secure all of the Trust as a security against such borrowings
- d) The TRUSTEES shall be at liberty to sell and/or realize the Trust property, if and when acquires, in future on funds and invest the sale proceeds therefore or any other money, being part of the Trust fund, in any manner as the TRUSTEES may from time to time think fit, within the scope of this Trust and within the scope of law.
 - The TRUSTEES may lend money either with or without security.
- Trust for spending in future for any of the objects of the TRUST in accordance with the provisions of the law including the income to-law applicable for the time being.
- g) The TRUSTEES may create a Corpus Fund out of any specific grant or donation or out of the income of the Trust and invest the same in suitable long term investments and may out of the sale proceeds or any part thereof appropriate such money or part thereof for all any of the charitable objects, and purposes of the Trust.
- h) The Managing Trustee or the TRUSTEES may appoint regular,
 permanent, part-time or honorary staff, if necessary and according to the



requirement for managing or working of the Trust and use the Trust funds for payment of their salaries, compensation, expenses, etc.

- i) The TRUSTEES may let or hire out any movable or immovable properties belonging to the Trust for such period and at such rent or charge and on such terms and conditions as the TRUSTEES in their discretion may think fit in the interest of the Trust.
- j) The TRUSTEES may construct laboratories dispensaries, clinics, operating theatres, hospitals, eye-bank and/or purchase or take on lease of any of all of them and such other equipment, instruments, apparatus, machinery, and/or vehicles as may be necessary for carrying out the objects and purposes of the Trust.
- K) The TRUSTEE may subject to the provisions of law., contribute to the funds of any professional association, individual, firm, corporate body, society, organization or institution, which in the opinion of the TRUSTEES is beneficial to the Trust.
- 1) The TRUSTEES may conduct workshops, conferences, seminars, meetings, forms, symposium and create opportunities for medical professional, researchers, scholars, technicians and interested persons to meet regularly to exchange views, notes, research findings and inventions and to publish news letters, books magazines, periodicals and/or leaflets related to the aims, objects and purposes of the Trust.
- . m) The TRUSTEES may reimburse themselves for all expenses actually incurred or spent by them in connection with the Trust or affairs of the Trust or that duties relative thereof.
- n) The TRUSTEES may join, co-operate or amalgamate this Trust with other.



- o) The TRUSTEES may institute, defend, adjust, settle, compromise, compound, and refer to arbitration, all auctions, suits, claims, demands and proceedings regarding the Trust property or the Trust funds.
- p) The TRUSTEES may appoint constituted attorney (s) or agent (s) and to delegate to such attorney (s) or agents (s) all or any of the power vested in them under this Trust Deed and from time to time remove such attorney (s) or agent (s) and to appoint other or-others in his or their place (s).
- q) The TRUSTEES have power to frame rules and regulations to carry out and to give effect to the objects and the purposes of the Trust and/or managing the affairs of the Trust and to alter, and/or amend the same from time to time.
- r) The TRUSTEES may do any other thing or things which is/are incidental and conducive to the attainment of the aims and objects or any one of them.

10 MEETING:

- a) The managing Trustee for the time being shall be authorized to call a meeting of the TRUSTEES by giving notice in writing or oral to the other TRUSTEES.
- b) Managing Trustee along with two or the TRUSTEES shall from a quorum for a meeting of the TRUSTEES.
- c) All matters will be decided unanimously by the managing Trustee and the majority of the TRUSTEES at a meeting convened for that purpose.

- d) Resolutions may be passed without holding a meeting of the TRUSTEES by circulating in writing the proposed resolutions, which must be endorsed by the Managing Trustee and two thirds of the TRUSTEES, if resolutions are endorsed in this manner, they shall be as valid and effectual as resolutions passed at a meeting of the TRUSTEES.
- e) The TRUSTEES shall keep or cause to be kept a minute book of the proceedings of the meetings.
- f) The TRUSTEES may, if so decided unanimously, dissolved the Trust and Transfer the Trust and / or such part of portion thereof as shall, for the time being remain in the hands of the TRUSTEES, or the investment and properties of the Trust or a part thereof to any other institutions or trust for pursuing the objects specified, but no part of the trust funds, assets or liabilities shall be transferred to the SETTLER or any of the TRUSTEES at any time or under any circumstances upon dissolution.

ii FINANCE & ACCOUNTS:

- a) It shall be lawful for the TRUSTEES to settle all accounts and to compromise, compound, abandon or refer to arbitration any action or proceedings or dispute, claim, demand or things proper for such purpose without being responsible for any loss accessioned thereby.
- b) It shall be lawful for the TRUSTEES to borrow money either on the security of any property belonging the Trust or otherwise to fulfill any or all of the aims and objects of the Trust, and it shall be lawful for the TRUSTEES to make this borrowing and the payment of any interest that may result on such terms and conditions as they think fit.

- c) It shall be lawful for the TRUSTEES to apply to the government, public bodies, urban, local, municipal, district and other bodies, corporations, companies, or persons for and to accept grants of money, aid, donations, gifts, subscriptions and other assistance with a view to promoting the aims and objects of the Trust and to discuss and negotiate with the government departments, public and other bodies, corporations, companies or persons, all schemes and other works and matters within the aims proper condition upon which such grants and other payments may be made.
- d) The TRUSTEES shall ensure true and accurate accounts to be kept of all money received and spent and of all matters in respect thereof in the course of the management of the TRUST property or in relation to the carrying out of the aims and objects of the Trust as well as of all assets, credits and affects of the Trust property.
- e) The accounting year of the Trust shall be financial years i.e. year ending 31st March every year.
- f) A firm of chartered Accounts, appointed by the TRUSTEES shall audit the accounts of the trust every year.

APPLICATION OF TRUST PROPERTY / INCOME:

- a) It is expressly declared that no part of the Trust property or income of the Trust shall be applied from any purpose outside India or for any purpose which is not a public **charitable** purpose in law and all provision thereof shall be construed accordingly.
- b) The Trust property and the Trust-Fund shall be and remain irrevocable for all times.



JURISDICTION:

- a) The Trust shall be authorized to function throughout India.
- b) Any legal disputes, claims or litigation with the jurisdiction of the law arise; they will only be considered valid if they are lodged within the precincts of the city of Ranchi.
